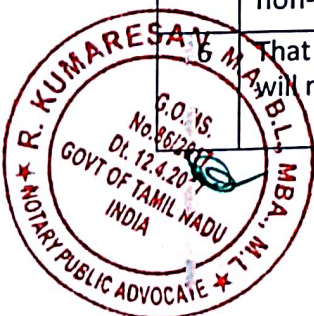

AFFIDAVIT

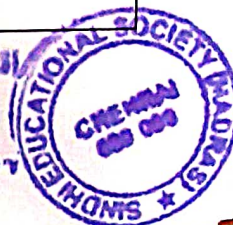
